

Terms Of Use

Please read below written conditions in order to use this website www.cundacallistohotel.com operated by Cunda Callisto Hotel & Spa (here in after referred to as "CALLISTO") residing in Mithatpaşa Mah. Mevlana Cad. No:68 Ayvalık/Balıkesir. By accessing www.cundacallistohotel.com (hereinafter referred to as the "Website") you agree, declare and undertake that you have read this Terms of Use, understood its contents and unconditionally accept those that are stated here in, and shall not assert any objection or plea in relation to these terms.

CALLISTO may amend the Terms of Use and any content which appears in the Website at any time without any prior notice to the visitors of the Website. Such amendments shall become effective on the date that they are posted. Continued access to the Website after those amendments become effective shall be deemed acceptance of such amendments by the visitors.

1. DEFINITIONS

Service(s) means applications and content in the Website which enables Users to obtain information on the services offered by Hotels that are owned by CALLISTO, to book rooms for accommodation, to make payments or to buy other products and services offered.

Content means any and all visual, literary and audio images such as any kind of information, text, file, picture, video, number, etc. that are posted and accessible on the Website.

User means any natural or legal person that access and/or use the Website.

Hotel means any of the accommodation facilities owned or managed by CALLISTO.

Cunda Callisto Hotel & Spa, Mithatpaşa Mah. Mevlana Cad. No:68 Ayvalık / Balıkesir means the Hotel located at the address.

Website means the website with the domains name <u>www.cundacallistohotel.com</u> and sub-domain names connected to that domain name where "CALLISTO" Services are provided.

2. TERMS OF SERVICES

2.1. Users agree and undertake not to book reservations for the purpose of reselling them to third parties or offering them for sale or putting them up for sale on other websites. Available services on the Website are only for personal and non-commercial use of Users or persons they are legally authorized to represent, and cannot be used for another purposes. For this reason, Users agree and undertake that

they are not entitled to assign any of the rights and obligations they assume, by using the services available on the Website, to third parties.

- **2.2.** User agrees and undertakes not to reproduce, copy, distribute, process any image, text, audio-visual image, video clip, file, database, catalogue and list contained in this Website, or engage in any commercial activity or act in any way that constitutes directly and/or indirectly unfair competition.
- **2.3.** User agrees and undertakes not to engage in activities, with regard to this Website, which may likely to cause unfair competition under the provisions of the Turkish Commercial Code, not to commit in any act that may impair CALLISTO's and/or any third party's personal or commercial reputation, or infringe or violate personal rights, and to act in accordance with the law, public order and ethics, to take necessary measures required by the law and comply with the procedures, not to commit acts that are illegal, criminal, offensive, or that violate personal rights, intellectual rights, copyrights, trademark rights and property rights.

CALLISTO will not use your information for previously unspecified purposes. We may also use your information to personalize our services and marketing efforts, and to carry out statistical analysis by collecting your IP address, which pages you are visiting on our site, your domain type, browser type, and the time of your visit.
- **2.5.** CALLISTO has the right to create remarketing lists based on which pages you visit, how much time you spend on those pages and how many goals you completed, through the cookies associated with your browser, in order to achieve online behavioral advertising and marketing. CALLISTO also enjoys the right to utilize marketing automation tools, and to provide personalized messages, offers, and suggestions. We may show targeted adds related to your interests at this website or other websites in the Display Network. - **2.6.** By utilizing the Website all Users acknowledge and agree that it is illegal to disassemble, modify, reverse engineer all or part of the Website, to try to access the site in a manner that in any way may prevent, impair or interfere with the communication or technical systems of the Website, to use "screen scraping" software or systems such as automated programs, roots, spiders, web crawlers, software for data mining or data trawling, etc., to use digital tools or manual processes on the Website, to access data or software of other users without authorization, to use the Website and its content in contrary to the terms and limitations described herein. 5. GOVERNING LAW AND JURISDICTION

This Agreement shall be governed by and construed in all respects in accordance with the laws of Republic of Turkey without regard to its conflict of laws rules. Istanbul Central (Çağlayan) Courts and Bailiff's Offices shall have exclusive jurisdiction over any disputes that may arise out of or in connection with this Terms of Use.

6. VALIDITY

In the event that any of the provisions of this Terms of Use is deemed invalid in accordance with the applicable law or declared to be invalid by a competent legal authority or court, the validity of the remaining provisions shall not be affected and continue to be in full force and effect.

7. EFFECTIVE DATE AND ACCEPTANCE

Terms of Use shall become effective at the date that it is posted on the Website by CALLISTO. Users shall be deemed to have accepted the provisions of this Terms of Use and any amendment to it by using the Website.
